

## Nationals 2018 Host Nevada Don Christensen, Host Director

Planning is underway for the 2018 National High School Mock Trial Championship in Reno, Nevada. The "Biggest Little City in the World" is ready to host more than 1,500 students, coaches, family members and volunteer judges, team officials and organizers. A Steering Committee is in place to oversee competition logistics, volunteer recruitment and budgeting. The Committee is ahead of schedule on most projects, including the drafting

of the case to be argued during the competition.



**Fundraising efforts are going strong.** The Nevada Bar Foundation has donated \$50,000 to host the event and has received \$20,000 and \$30,000 grants from two private foundations in Reno. Additional fundraising events have taken place with more in the planning stages.

**Reno has much to offer.** Downtown Reno has several attractions all within walking distance of the host hotel, including the Reno Aces Ballpark. The Steering Committee has identified the following locations for team events and receptions.

The National Judicial College brings judges from across the country for training at its facility in Reno. In addition to hosting the Judge's Reception, the College is also working with the Steering Committee to schedule a judges training in the days before the competition. We anticipate many of those judges taking an extra day or two to stay and judge the competition.

**Sleeping accommodations are set.** We have selected the Silver Legacy Resort and Casino as the host hotel for the competition. Located within blocks of the downtown courthouses, the Silver Legacy is completely connected to two other resorts and hosts an array of entertainment and dining options on site and within walking distance.

A room block has been set aside and favorable rates negotiated for the 2018 NHSMT competition.



**Courtrooms are reserved.** Competitors will be spread across 24 courtrooms in multiple venues within a few blocks of each other: the Second Judicial District Courthouse, the Mills B. Lane Justice Center and at the Bruce R.

Thompson Federal Courthouse, with space and seating available for competitors and observers. Reno City Hall has also been made available at no cost as an operations center.

**We're going online.** A dedicated website for the 2018 competition is under development and is set to go live soon. The site will house all information related to the competition and include online registration forms, judging and liaison volunteer forms, and an online donation portal. The site is populated with rotating photos of downtown Reno. It is also geared with a younger audience in mind, featuring live streaming from Instagram followers using the #natlmocktrial handle.



**Forging Ahead.** In the upcoming year, the Steering Committee's focus will shift its primary focus to communications regarding the competition, recruitment of attorneys to serve as scoring judges, and obtaining assistance from local volunteer groups to help shepherd students between events and courthouses. This will include continuing dialogue with members of our local and statewide judiciary, local and specialty bar associations, and informing/inviting attorney participation.

Welcome to Athens, Georgia, the Classic City; steeped in history and home of the University of Georgia (UGA), the oldest land grant university in the country, chartered in 1795. A true southern college town, Athens is a unique mix of the past, present and future, and we are excited to be your host for the 2019 National High School Mock Trial Championship. The Georgia High School Mock Trial Program, along with the State Bar of Georgia and its Young Lawyers Division, is already hard at work making plans for the 2019 Nationals, to be held the weekend of May 16-18.

Teams will be immersed in the city's history throughout the weekend as the competition's events take place both in the picturesque downtown and on the campus of the University of Georgia. But it isn't just antebellum history that can be found here; Athens is also the site of the first powered flight in the state of Georgia as well as the birthplace of several music groups, including the B52s and R.E.M. There is so much to see and explore, and we will highlight more as the event draws closer.

The Hilton Garden Inn will serve as the headquarters for team registration and information, with students being housed in one of three hotels in the middle of downtown Athens. Competition rounds will take place at the Athens-Clarke County Courthouse and the Classic Center, the city's jewel of a convention center. The Classic Center will also play host to all of the practice rooms, various meetings on Thursday and the Awards Gala Saturday night.

The 2019 competition will be a unique experience for the mock trial family in that it will be one of the first visits to a true southern college town and we are excited to share this unique part of Georgia and the south to everyone in 2019!

## **Committee Reports**

The National High School Mock Trial Championship, Inc. is an all-volunteer organization. There are no paid staff members who coordinate the activities of the NHSMTC. The governing body of the NHSMTC, Inc. is the Board of Directors of the NHSMTC. The 2015-2016 Chair of the Board is Dewain Fox (AZ), Vice Chair is Laura Wesley (CA), Treasurer is Paul Kaufman (PA) and Secretary is Rebecca Britton (NC). ### Nominating Committee David Berlin, Committee Chair

A scheduled election will be held during the State Coordinators' meeting on May 11 in Hartford. There are 4 at-large Board positions up for election this year. The at-large positions expiring in May are currently held by Ronald C. Appleby (NJ), David Berlin (NM), Paul Kaufman (PA) and Laura Wesley (CA).

The 2015 Host Director, Gordon Widenhouse Jr. (NC), term expires in May 2017 and has been filled by 2019 Host Director, Michael Nixon (GA). The Host Board Director, currently held by Susan Nusall (AZ), will expire in May 2017. These individuals will be replaced when a state is awarded a bid to host the National competition and when the chair re-appoints Ms. Nusall or appoints someone new.

Board members are required to attend (in person) the two regularly scheduled board meetings in October and May each year. According to the by-laws, interested candidates are to submit their letter of intent to run to the Chair. He has, however, designated that Nomination Committee Chair (David Berlin) be sent the letters. They are to be received no later than March 15, 2017. ### Long-Range Planning Committee Laura Wesley, Committee Chair

In October, coordinators were invited to take a survey to discuss the future of NHSMTC and how the organization should spend its resources. At the October Board meeting, the committee reported to the board of the survey results. 62% of the survey respondents reported that more seed money would assist in their ability to host a future NHSMTC. An increase in seed money was discussed but keep in mind that the organization should always keep at least \$150,000 in reserves in case it was ever called upon to host a national competition.

Additionally the coordinators reported that funds should be used to help the host site with some of the tasks associated with hosting such as the national website, registration system, etc. It was discussed that the board would look into what it would costs to create and maintain a registration system as well as a website that could be passed on from host to host. The second highest priority as reported in the survey is providing a platform to collect and house PowerPoints, agendas, videos, volunteer and school recruitment fliers, for use by state coordinators. The board is looking into the technical aspect of storing and organizing the sample documents on the NHSMTC website. The plan is to have samples in place by May and then a process for collecting resources from coordinators to share with other members. Lastly, if there are any remaining funds, funding for a mini grant program would be considered. An ad hoc committee was created to start the process of creating criteria for a mini grants program that would support innovative ideas to support new components of individual state mock trial programs or grow existing programs.

### Policy Committee Cynthia Cothran, Committee Chair

At the Board's October meeting, the following language was added to policy number **38.** Policy for **Responding to Questions:** 

NEW: If the host director has any questions about the competition, the question(s) should be proposed to the Board Chair or Board Host Director.

### Rules Committee Pete Jones, Committee Chair

At the Board's October meeting in Hartford, a few rule changes were approved.

- First the Board adopted a set of Rules for the Artist competition.
- Second the Board amended Rule 4.14 to make it clear that in the Championship Round a team may not object to being videotaped, tape recorded, live steamed or photographed by the host organization.
- Finally the board examined team competition and amended Rules 1.4 and 3.2. Under the present rules there were 8 official team members who could serve as a witness and/or attorney. In addition to the present 8 official team members the rules allowed for a 9<sup>th</sup> person to act as a time keeper who was limited to the time keeping role only. The board has amended its rules so that 9 will be

the maximum number of official team members. Any timekeepers must come from this official 9. Subject to Rule 3.2 and 3.4 any member of the official team can be a witness, attorney and/or timekeeper. Any timekeeper must continue to go through the training outlined in Rule 1.4.

## California

The Constitutional Rights Foundation (CRF) is concluding its 39th Annual Los Angeles County Mock Trial competition. This November, over 2,600 high school and middle school students headed to court to try the case of *People v. Awbrey*. This year's case is the trial of Cameron Awbrey, a restaurant owner, who is being charged with human trafficking and false imprisonment of Lin Stark, an immigrant from the country of Tanterra.

## Georgia

The Georgia High School Mock Trial Competition is in its 29<sup>th</sup> season with 124 teams registered for the competition. The Regional Competitions will take place in 16 locations around the state the weekend of January 28, with 48 teams advancing to the District Competitions on February 18. From there, the eight District Champions will meet for the State Finals Competition March 4 to determine which team will be representing Georgia in Boise.

The season started with our 19<sup>th</sup> annual Law Academy in Atlanta over the weekend of September 15-18. Fortyfour students spent the weekend honing their trial preparation and practice skills with attorneys and judges in the program, finishing with the Student Bar Exam. The students had to craft and present a 3-minute closing argument for the weekend's case in the three days of the Academy.

The 2017 case is an original problem written by Georgia's Problem Subcommittee. During the semi-final game of Georgia's high school co-ed softball championship, Joey Cobb was attempting to throw out Bryson Harper at the plate from left field. However, Joey's throw connected with the Harper's head, knocking him/her out on the spot.

(Harper's helmet had flown off rounding third base, which was not an uncommon occurrence for Harper.) Harper claims that Joey's throw was intentional and offers Joey's well-known arm and accuracy as proof of Joey's ability. Harper and Joey have a long history of competition, both during the school year and on the same summer travel league. Other witnesses in the case include Casey Dansby, the shortstop on the field at the time; Coach Jamie Dugan, Harper's 3<sup>rd</sup> base coach (and the head coach of the summer travel team everyone plays on); Aubrey Williamson, the local radio play-by-play announcer who was working the PA system for the game; and Gerry/Geraldine Brand, a college/pro scout. Joey hit Harper; that's indisputable. Was it intentional?

## Illinois

The 2016 ISBA High School Mock Trial Invitational was held on April 2 and 3, 2016, at the University of Illinois' College of Law in Champaign. Thirty-eight schools from across Illinois participated in the event. The winning team was Timothy Christian High School, which went on to compete in the National High School Mock Trials in Boise, Idaho.

The 2016 Invitational was successful due to the hard work of the ISBA's Standing Committee on Law-Related Education, Mock Trial Coordinator, Katy Karayannis, and the many judges, attorneys, law students, undergraduate students, and others who generously volunteered their time to assist with the program. First, by providing more information to teams about expectations for competitors about how to be successful. Second, by establishing a stronger relationship with coaches about competition structure.

Minnesota has 128 teams competing; 49% are in rural areas outside of the Twin Cities, 36% are in the Twin Cities metro suburbs, and 15% are in the inner-city schools. We've also focused on recruitment of diverse members to serve as judges, coaches, and on the Mock Trial Committee.

To meet these goals and increase awareness, we offer grants to help offset the costs for schools to participate. We've also launched a program through which schools can apply for courtroom attire donations for members of their team who are in need. We cannot guarantee that every application will be answered with a donation, but we sure hope to satisfy as many as possible. We've been soliciting and collecting suit donations from our MSBA members.

Once we have an opportunity to gauge the need from teams, we may try to solicit businesses to offer significant clothing discounts to our students, however, that is down the road. This program is being organized by Wynne Reece, MSBA Mock Trial Committee member and attorney coach, and Breck School (2010 NHSMTC).

Since Civic Education is being stripped out of schools, we've also added a segment in our training for students. This year our focus is on the upcoming election, specifically the Minnesota Supreme Court. Students will learn the importance of our judicial system and why voting for judges is important. We will have a new topic every year that relates to what is happening in our community.

## **Nevada**

### **New Jersey**

After years of trying, Metropolitan High School's mock trial team finally defeated longtime rival Greenward Academy in the Metropolitan County finals, only to find their victory dampened by allegations of cheating. Did a student blogger from Greenward defame senior Shea Simmons, a star student-attorney from Metropolitan, causing Simmons to lose a much needed college scholarship? The case, *Shea Simmons* v. *Delaney Barnes and Cameron Winchell*, was adapted with permission from the Nebraska State Bar Foundation from its 2011-2012 mock trial case, *Phoenix O. Perdante* v. *Dalton Academy*. ## **North Carolina**

2016 has been a busy year in North Carolina. Our fourth annual summer mock trial camp, held in Chapel Hill at the end of July, brought together more than 60 students and coaches, with campers coming from as far away as Wisconsin and Florida. Legal professionals instructed the participants on every aspect of mock trial, and college "mockers" mentored the student teams as they prepared to argue one side of the camp case in the culminating trial scrimmages.

Even more exciting, this year marks the 25<sup>th</sup> anniversary of the start of our statewide mock trial program. CCCE President Gordon Widenhouse was instrumental in initiating this remarkable opportunity for our youth, and he and our Board are excited to mark this milestone accordingly. Plans are in the air for a spring soiree, bringing together alumni, volunteers, and supporters to celebrate!

Our 25<sup>th</sup> anniversary case, *Gabriel Torres v. Arcadia Police Department*, presents our students with ethical quandaries they face in their daily lives: bullying; acceptance of differences (in abilities, interests, religion, and ethnicity, school safety and school discipline, and reasonable versus excessive force. As one team advisor wrote to us a few weeks ago, "The conversations that have (and will) take place during practice, preparation and competition are about far more than simply mock trial. They are about how we want our society to function....I want to convey

my sincere appreciation for the way you have used your platform to promote dialogue on these fundamental issues."

Lastly, because of the growth in the program during the last few years, we added a ninth regional site for the 2016-17 season. More than 70 teams have already enrolled (deadline is Dec. 9), and we expect our final numbers to exceed 90 teams. Several schools are fielding three teams for the first time ever, and a number of new schools and clubs have joined the program this year. We look forward to seeing the case brought to life on February 4, 2017 and again at state finals in Raleigh on March 10-11.

## Ohio

The Ohio Center for Law-Related Education (OCLRE) is happy to introduce the 34<sup>th</sup> annual Mock Trial Case, where this year students will consider a case of defamation of a public official by a news station. In Ohio, Governor Pat Justice is a popular incumbent in a re-election bid for Governor. During the campaign, Trillium High School's We the People club invited Governor Justice to speak during the lunch hour. Their principal, Principal I.M Veritas, was a rival of Governor Justice

in college, and once the two were alone, an argument ensued, and the Governor left the school angrily. As the Governor left, Principal Veritas suffered a fatal brain aneurysm and died. A student reporter heard the argument and reported to a local news affiliate CAT News that the Governor had killed the principal. While it was disproven quickly, the story went viral. Governor Justice lost the election, and has now filed a civil suit against CAT News, alleging defamation. The former Governor will seek to prove that the station published the story with reckless disregard to the truth, and that the story damaged his/her reputation and cost him/her the election.

The first competition will take place in 27 districts across the state on January 20<sup>th</sup>, and the Regional competition will take place in nine locations across the state on February 10. Our annual state competition will take place on March 9-11 in Columbus, Ohio. The Ohio channel will livestream the final round, in the Ohio Statehouse on March 11<sup>th</sup>. The Ohio State champion will represent Ohio in the National competition in Hartford, Connecticut. More than 3500 students from close to 200 high schools will try for a chance to represent Ohio at Nationals this year. OCLRE is lucky to benefit from the assistance of over 1000 volunteers across the state. We currently have volunteer coordinators in 27 cities across Ohio who make the competition possible. Additional volunteers help write the Ohio Mock Trial case, serve on our competition committee, and serve as judges for each level of the competition. One such volunteer is Jessica Paine, who has been a District and Regional coordinator for Cuyahoga county (Cleveland-area) for several years, and recently served as a member of our competition committee. Cuyahoga county hosted teams in close to fifty courtrooms, and coordinated over 200 volunteer judges.
