Welcome To Raleigh! By North Carolina Host Director, M. Gordon Widenhouse, Jr.

The Carolina Center for Civic Education, which is hosting the National High School Mock Trial Championship, is moving into the home stretch!

As the capital city of North Carolina, Raleigh offers the advantage of numerous museums, an active downtown area with ample restaurants and a burgeoning upscale residential population, a free downtown shuttle bus, a major airport (RDU) located only fifteen miles from downtown, and an active Visitors Bureau eager to provide detailed information on local and statewide attractions to our guests.



Known as the City of Oaks, Raleigh has a large sculpture of an acorn that it drops every New Year's Eve. A statue of Sir Walter Raleigh, for whom the city is named, moves around the downtown area. There are other historic buildings in the downtown area, including the State Capitol and the Justice Building, home of the Supreme Court of North Carolina. Each

year, Raleigh hosts a very enjoyable Artsplosure event. It will coincide

with NHSMTC coming to Raleigh in May 2015. Artsplosure will provide opportunities to experience some of the best in local visual and musical art experiences in a very informal setting.

The trials on Friday and Saturday will be held at the new Wake County courthouse (in two connected buildings), the nearby Campbell Law School, and the North Carolina State Bar. The Championship Round will be in the ceremonial courtroom in the Wake County Courthouse, a beautiful large courtroom.

There are two host hotels, the Marriott and Sheraton. Both are within two blocks of the courthouse and are next door to the Raleigh Convention Center (site of the Saturday Awards Gala). Rooms will be available on Wednesday and Thursday for team practices as well as the meetings of the National Board and the State Coordinators.

On Thursday evening, the Pin Exchange will be at the Sheraton. It will include a buffet of Southern cuisine and intermittent entertainment by circus performers, both indoors and outdoors.

On Friday evening, there will be a scavenger hunt in the downtown area in conjunction with Raleigh's annual Artsplosure celebration. There will be food trucks in the area especially for attendees of the competition. There will be a reception for judges and lawyers on Friday evening at the North Carolina State Bar, which is also in downtown Raleigh.

On Saturday evening, the Awards Ceremony will include a dessert buffet, followed by a dance, in the Raleigh Convention Center next door to the Sheraton and Marriott. We have some special features for this closing portion of the championship that we believe will make it memorable for everyone involved.

HOTEL INFORMATION Sheraton Raleigh Hotel

Site of the Thursday Pin Exchange and located only two blocks from the courthouse, the Sheraton Raleigh Hotel is one of our two headquarters for the Championship. The hotel is located at 421 South Salisbury Street, Raleigh, NC 27601. Room rates are \$129/night for singles – quads; \$169 for Club; \$400 and up for suites. Free internet is

Raleigh Marriott City Center

Located beside the Sheraton and only two blocks from the courthouse, the Marriott is also a headquarters for the event. Most team scrimmage rooms are in the Marriott; the Thursday pre-event meetings for coaches, timekeepers, and State Coordinators will also be held here. The hotel is located at 500 Fayetteville Street, Raleigh, NC 27601. Room



rates are \$145/night for singles – quads. Free internet is provided; rates do not include parking fees or applicable taxes. Transportation— Air

Neither of the tournament hotels provides free shuttle service to the airport. Taxi cab companies and rental cars are available at RDU. Estimated fees: Super Shuttle (\$40 one-way; reservations required); taxi fare (\$45 one way). Check back for updates as we are working to arrange reduced rates for our event attendees.

Judging Panel Sign-up and Other Volunteers Sign-up

Attorneys and Judges interested in volunteering to judge the 2015 National High School Mock Trial Championship are encouraged to complete a volunteer form as soon as possible. Each round of the tournament will be judged by a panel comprised of one presiding judge and three scoring judges. All judging materials will be provided electronically to judging panel members several weeks prior to the Championship. An orientation will be provided on the days of the Championship for judges prior to the beginning of each round. Judges and attorneys may volunteer to judge one or more rounds at their convenience. Judges for the National High School Mock Trial Championship are required to have previously judged a minimum of two rounds of a mock trial competition. If you would like to volunteer as a judge for Nationals, please contact your local Mock Trial State Coordinator to volunteer at one of the state tournaments.

Nationals 2016 Host Idaho!

Go West Young Men (And Women)!

Three things you likely know about Boise, Idaho:

1) Boise is the capitol of the state of Idaho, which is either the furthest eastern point of the

Pacific Northwest or the furthest western point of the Rocky Mountain West, depending on who you ask.2) Boise is home to the famous Boise State University blue football field (sometimes called The Smurf Turf).3) In May 2016, Boise will serve as host to the National High School Mock Trial Championship.



Three things you will learn when you get here in 2016:

1) Boise has the largest Basque population outside of Spain and you will get to experience the city's Basque culture and heritage (and most importantly food) when the Pin Exchange is hosted on Boise's Basque Block.

2) Downtown Boise offers a lot of fun and vibrant restaurants and shopping, all within a short walk of the Boise Centre on the Grove and the Grove Hotel, which will serve as the central location for the event.

3) Boise is home to the gorgeous Ada County Courthouse, built in 2002, that will host all but the final round of the national competition.

The host organization for the 2016 National High School Mock Trial Championship is the Idaho Law Foundation, coordinated by its Law Related Education Program. Law Related Education oversees many civic education activities, including Idaho's High School Mock Trial Program. The hub for the competition will be the Boise Centre on the Grove, centrally located in Downtown Boise. Our registration and information desk will be at the Centre. The Centre will also have rooms for practice sessions and will likely host team meals on Fridays and Saturdays.

Our local court has committed to the use of up to 27 courtrooms at the Ada County Courthouse. The Ada County Courthouse will be used for the first four rounds of competition on Friday and Saturday. Saturday's championship round will be held in the main hearing room at the newly renovated Idaho Statehouse.

The main hotel for the event will be The Grove Hotel, but to cover the number of rooms we will need, the National Host Committee has also booked blocks of rooms at other hotels in the downtown corridor. All hotels offer free shuttle service from the Boise Airport.

Boise's mock trial event will provide fun activities for teams and volunteers. The Pin Exchange will be held on Thursday evening on the Basque Block, which includes the Basque Museum. Basque food will be served and we are working to get some Basque dancers to come and perform that evening. Thursday night's Judges' Reception will be held at Holland & Hart, a northwest regional law firm with offices in Boise that has just opened up new offices with a spectacular view of the foothills surrounding Boise. And finally, the Awards Gala will be hosted Saturday evening at the Boise Centre on the Grove. We have planned a dessert bar before the awards ceremony and a dance for teams after the ceremony.

And finally, our case will be... you know we can't tell you about that yet. But we have been working hard to develop the case and trust me; it's a good one with lots of rich Idaho history and culture.

The Idaho Law Foundation looks forward to hosting the 2016 National High School Mock Trial Championship. We are excited to share our Boise community with the mock trial nation, highlighting our courts and our beautiful state as we plan a memorable event for teams, their families, state coordinators, and the many volunteers who will visit us. News and Notes From Around the Nation

California

Constitutional Rights Foundation (CRF) just concluded its 37th Annual Los Angeles County competition. This year we had 94 high school teams and 42 middle schools teams compete. CRF created a Clerk and Bailiff webcast for the Los Angeles County Competition at <u>http://crf-usa.org/mock-trial-los-angeles/la-mock-trial-download-</u> <u>forms.html</u>.

CRF is excited to host its 34th Annual California Mock Trial State Finals in Riverside, March 20-22, 2015. The program currently involves 36 California counties and over 8,000 students. This year's case, *People v. Shem*, is the trial of Evan Shem, who faces one felony count, theft by larceny, for the theft of Treason, a painting by Fletcher Yazoo. Treason is owned by wealthy art collector Marty McCulloch, with a pretrial argument involving the Fourth Amendment. Georgia By Michael Nixon, State Bar of Georgia

The Georgia High School Mock Trial Competition registered 139 teams for the 2015 season, the highest number in many years. The teams will compete in 16 Regions across the state the weekends of January 31 and February 6. The season began with the 17th annual Law Academy, held at the State Bar of Georgia's conference facilities over the weekend of September 18-21. Students from around the state participated in small and large group seminars led by judges and attorneys involved with the program. The weekend culminated with the students taking the Student Bar Exam Sunday afternoon, where 15 students were admitted into the Student Bar of Georgia, 5 with Honors.

The case for the 2015 season is Stuart vs. Garfunkel Property Group. The originally written case centers on a confrontation between the new head of security at The Mall at Carley Corners and one of the elderly mall walker patrons. The confrontation escalated to the point where the security guard used a Taser-like device on the walker after the guard felt threatened by the walker's actions. The walker is suing the mall management company for negligent hiring and negligent retention of the guard, saying the company should have known the liability the guard would have been as head of security. The guard is testifying for the plaintiff against the former employer, claiming that their actions were in line with what the mall wanted.

We will again be hosting the Craig Harding Memorial Court Artist Contest during the Regional competition in the spring. Through the partnership with the Savannah College of Art and Design (SCAD), the State Champion Court Artist will be travelling with the state Mock Trial Champion team to Raleigh to draw at the National Competition.

Last season was the first season with the new District level of competition for the Georgia program. 48 teams were able to compete at the next level beyond the Regional competitions, with 8 advancing to the State Finals Competition. Many felt that the level of competition at the State level was much better than in years past and teams enjoyed the opportunity to compete after the Regional weekend. We are excited to see how the second year of the Districts adds to the competitiveness of the statewide competition.

Idaho

The Idaho Law Foundation's Law Related Education Program is getting ready for the upcoming 2015 Idaho High School Mock Trial Competition. Three regional tournaments will be hosted in different parts of the state on in late February and early March. 12 teams will advance from the regionals to the state competition to be hosted in Boise on March 19 to 21.



This year for the first time we sent a marketing postcard to all secondary schools in Idaho, hoping to recruit new teams to participate. We have had six new schools express interest in participating, with three of those teams already registering for

the competition. In addition to our Idaho teams, Idaho will also be hosting a team from Montana this year, since Montana does not currently have a high school mock trial program.

Illinois

The 2014 ISBA High School Mock Trial Invitational was held on March 8 and 9, 2014, at the University of Illinois' College of Law in Champaign. Forty-two schools from across Illinois participated in the event. The winning team was St. Charles North High School, which went on to place tenth in the National High School Mock Trials in Madison, Wisconsin.

This was the first year the event was hosted by the College of Law. The new location was well-received by participants and volunteers. Moreover, the College of Law welcomed the event, recognizing that hosting the program and establishing a cooperative relationship could mutually benefit everyone involved.

The 2014 Invitational was successful due to the hard work of the ISBA's Standing Committee on Law-Related Education, Mock Trial Coordinator, Marley Nelson, and the many judges, attorneys, law students, undergraduate students, and others who generously volunteered their time to assist with the program. The program was also made possible by the sponsorship of the ISBA, Illinois LEARN, the Illinois Trial Team, and the Diversity Scholarship Foundation of Chicago, and by the generous support of many others. The ISBA's Standing Committee on Law-Related Education appreciates all of these supporters and invites any attorney, judges, or other legal professionals to join us next year for the 2015 ISBA High School Mock Trial Invitational at the University of Illinois' College of Law in Champaign on March 14 and 15, 2015.

North Carolina

Cold, confused, and drenched, high school student Justin Burke awakened and stumbled out of a makeshift lean-to on a mountainside. He and his friends from ForensiTech camp had gotten lost on an

evening hike and were stranded. It was now 3 am. As he lurched away from the shelter, Justin slipped, tumbled down the mountain, and struck his head on a rock, leaving him with serious long-term injuries. Months later, Justin's parent, Sydney Burke, filed suit against ForensiTech camp for gross negligence, claiming that the camp was liable for Justin's injuries.

A tragic tale – but thankfully, a work of fiction. Nearly 60 teams of students across North Carolina are learning about diabetes, spinal cord injuries, and wilderness first aid as they prepare to argue the original case of *Justin Burke v. ForensiTech, Inc.* Teams will compete at 8 regional sites on February 7, 2015, with the regional champions advancing to state finals at Campbell Law School in Raleigh on March 6-7.

Several new teams have joined the program as a result of our 2014 summer mock trial camps (which, thankfully, did not entail any students lost on overnight hikes!). Camps were held in three locations – Chapel Hill, Asheville, and Fayetteville – and even attracted more than a dozen students from neighboring states. Attorneys and judges from the local community led the teaching sessions, and experienced college "mockers" served as mentors for the camp teams.

In 2015 we plan to offer only one camp, in Chapel Hill, due to the time involved in hosting the National Championship in Raleigh on May 14-17, 2015. We look forward to sharing our southern hospitality with all of you in May!

Foundation An overnight school trip turns into a nightmare for a high

school senior who leaves the hotel after curfew without

permission. Are the student and parent to blame or the teacher and school district? That's the question students will tackle as they take on the roles of lawyers, witnesses and jurors in the 2014-2015 Vincent J. Apruzzese High School Mock Trial Competition sponsored by the New Jersey State Bar Foundation in cooperation with New Jersey's county bar associations and the New Jersey State Bar Association. Other mock trial competitions sponsored by the New Jersey State Bar Foundation include Law Fair for grades 3 - 6 and Law Adventure for grades 7 and 8. In both competitions teachers guide their pupils in creating an original criminal or civil case on ageappropriate topics. In the spring, winning cases are performed by the students who wrote them at the New Jersey Law Center in New Brunswick before an audience of fellow students acting as jurors. Judges and attorneys preside over both Law Fair and Law Adventure mock trials. For students in grades K - 2 the Foundation offers the "Mini-Court Teacher's Guide," which contains lesson plans and related classroom activities and resources designed to introduce legal concepts to young children. Things are gearing up for the Ohio Center for Law-Related Education's (OCLRE) 32nd High School Mock trial season! This year's case is about the 8th Amendment cruel and unusual punishment standards – a topic we have only selected once before in all our years of mock trial. The plaintiff in our case, Emerson "Money" Jones, is a former juvenile inmate and basketball prodigy who was grabbed by the wrist and slammed to the ground by a guard during a food fight. Later, the injury is diagnosed to be a sprained wrist at the prison infirmary, however after some time, Emerson is released and sees a doctor who determines the injury to be a fracture. Emerson is bringing suit against the correctional institute on two issues of cruel and unusual punishment – the excessive force of the guard, and the inadequate medical treatment of the nurse. Students are already having fun getting into character for witness statements of prison guards, inmates, and medical personnel!

OCLRE is looking forward to our district, regional, and state competitions in January, February, and March, and we can't wait to see who will win the state competition to head on to nationals in North Carolina! The center and our over 1,000 volunteers are prepared to welcome over 300 teams to this year's competition, impacting over 3,000 students across the Buckeye State. Never an easy task, but always a rewarding one. We wish the best of luck to mock trial teams competing all across our nation during the Winter and Spring.

Mock trial benefits attorneys at all stages of their careers. As mock trial continues to grow in popularity in Washington State and nationally, more and more attorneys come into the profession with the confidence that comes from high school or college mock trial experience. In high school, Nick Crown was recognized as one of the best "mock-trial attorneys" in the country at the national competition in Dallas in 2007. In college, he was

an All-American and helped found the University of Washington undergraduate mock trial program. Now a law student with a stellar academic record at the University of Virginia Law School, Crown says, "Mock trial taught me how to think." It set him up for success in law school "because the exams are just mini mock trials. You get a set of rules, a fact pattern, and you're tasked with thinking quickly to present the best arguments for each side. I learned how to do that from high school mock trial." Other attorneys not far out of law school credit high school mock trial with giving them a leg up in the profession. Coluccio says, "I think participating in mock trial gives me an invaluable sense of confidence in what I do every day, which is an incredible asset as a young lawyer. Standing before a judge for your first real hearing is slightly less intimidating after running a round before a state Supreme Court justice or a U.S. District judge." Stafford notes that he realized that when he got to law school and when he began practicing, "Mock law made real law easier. Doing mock trial so many years before had given me the fundamental analytical skills I needed to succeed as an attorney." To read the complete article visit:


