#### **Justice Franchini Golden Gavel Award**

While the deadline has passed to nominate someone for the 2018 Golden Gavel Award, it's never too early to start thinking about next year's award. The award recognizes an individual who has demonstrated a commitment to the goals and ideals of the national mock trial program.

The Justice Franchini Golden Gavel Award is named after a long time and avid mock trial supporter who passed away in 2009. His unfailing passion for helping young people learn about the law led him to serve each year as a judge in regional, state, and national mock trial competitions.

To nominate someone for the award, submit an essay of 500 words or less describing why the person is deserving of the award. Ideas to consider when making the nomination include the nominee's length of service to mock trial, the extent of their participation, the significance of their contribution, and how these qualifications help to further the goals and mission of National Mock Trial. In addition to the nomination essay, a person making the nomination can submit up to five letters of recommendation. Nominations remain on file and can be considered for up to two years after submission.

#### **Board & Committee Reports**

The *National Mock Trial Board of Directors* held their mid-year meeting in Reno on October 7, 2017. Highlights from meeting include rolling out a newly formatted newsletter (the one you're reading right now!), updated case drafting timelines for hosts, and updates to the Courtroom Artist Competition rules.

Full Reports for Board Committees are available in the <u>Members Area</u> of the National Mock Trial website, under the "Archives" heading.

Committee	Summary of Committee Actions
Archives	The committee discussed what types of archival information NHSMTC would like hosts to provide related to the National Championship. That includes in electronic format a list of all the awards winners, a copy of the awards program and a copy of the competition program.
Case	The committee discussed the draft of the 2018 National Case (Nevada) and the preliminary ideas for the 2019 National Case (Georgia). The committee also discussed amendments to the <i>Case Drafting Guidance</i> as it related to the timeline for hosts to submit drafts. The new timeline will allow more time for national committee review before the national competition.
Communications & Technology	The committee (acting then under different separate names) discussed changes to the NHSMTC policy manual as it relates to merging several committees into the Communications and Technology committee. The new committee will work with communications, the website and social media. The committee added an archives section to the Members Area making available former officer and committee reports to state coordinators. The committee is currently working on compiling a comprehensive media guide.
Finance & Development	The committee is exploring options for holding the NHSMTC funds in an account earning higher interest than its current account.
Newsletter	The committee proposed altering both the look and function of the NHSMTC newsletter as well as its publication dates. The newsletter will now be published in January (in anticipation of the next national competition) and in June (in reflection on the most recent nationals). Both dates follow the May/October Board meeting and announce relevant changes and information resulting from those board meetings. The new newsletter will be posted on the NHSMTC website and will consist of a one-page document with short headlines and summaries of information with links to "Read More " for full articles.
Nominating	The committee announced that four at-large director positions will be up for election at Nationals this year. Additionally, the Idaho Host Director's position is expiring. Any person interested in running for an at-large position on the board should submit a letter of interest to <u>David</u> <u>Berlin</u> by March 15 in order to be on the ballot in May.
Policy	The policy committee oversaw the merging of the two committees into the Communications and Technology committee via changes to the policy manual.
Rules	The rules committee formalized rules related to the Courtroom Artist competition.
Site Selection	The committee discussed the immediate need for a 2021 host and is working on contacting potential state coordinators. The committee also discussed streamlining information on the website to make it more user friendly for potential hosts.

Those who have hosted in recent years will attest that taking on this project is exhilarating and can benefit your state mock trial program. Carey Shoufler, Host Director for the 2016 national competition in Idaho shares that hosting was one of the best things that happened to her program. "I truly believe that anyone can host a successful national competition. We received a lot of support from both the National organization and our local community. If a market the size of Boise can do this, really anyone can. Plus, hosting nationals raised the visibility of our Idaho mock trial program. Our competition has grown by 30% in the last two years."

Gordon Widenhouse, the Site Selection Committee Chair knows that NHSMTC happens if, and only if, a state agrees to host it. "We all agree that national mock trial is worthwhile, otherwise we would not be involved. So, please, please, please talk to colleagues in your home state and rise up!"

# **Tips & Tricks**

Each year, Mock trial coordinators look forward to interacting with each other during the Coordinator's Roundtable. The meeting provides coordinators an opportunity to bounce ideas off of each other and get pressing mock trial questions answered. Starting with this edition of Mock Trial Matters, we will begin sharing some of these ideas between our visits to nationals.

Kristen Leeds from New Mexico asked if state coordinators could share some of their fundraising ideas. We received two responses:

- Sue Johnson from North Carolina: We have an ongoing grant to fund an outreach program to schools in under-served areas that covers on-site training materials and sessions and provide some need-based scholarships to our summer camps. North Caroling has also approached local bar associations to request sponsorships to defray the costs of security at our regional sites. Sponsors are recognized on the North Carolina website, in the monthly newsletter, and on the sports bags given to regional participants.
- **Carey Shoufler from Idaho:** As part of our recently created strategic plan, Idaho's mock trial program has developed a grant proposal for a Rural Mock Trial Initiative that focuses on the practical needs for smaller, more rural school districts that want to participate in mock trial. The project is being developed in cooperation with one of Idaho's universities and includes funds for recruitment, training, a cooperative team preparation model, and travel, lodging, and other costs that make it possible for teams to participate in competitions. This has been an effective model for us, as we have been able to connect our legal communities to school districts that don't normally have access to activities like mock trial.

For the next issue of the newsletter, we will be sharing tips for team and judge recruitment. What are some of the things you do to get people involved with your programs? Additionally, we are looking for other ideas to share in future editions.

Next time, our hope is that more coordinators will share the tips & tricks from their own states; this newsletter section will only be as good as the level of participation from our coordinators. ## Nevada - 2018



Head west where the sun always shines! Nevada is excited to host the 2018 National Championship in Reno, "The Biggest Little City in the World."

The theme of this year's championship is BELIEVE. The giant BELIEVE sculpture in City Plaza is inscribed with a quote that says: "Imagine with all your mind. Believe with all your heart. Achieve with all your might." The sculpture and quote will be featured throughout competition weekend.

Our host hotel is the Silver Legacy Resort, which features affordable rooms, free transportation to and from the airport and within easy walking distance of the competition courthouses.

When not in trial – or practicing for the competition – we have selected events and activities that will highlight our great city. Thursday night kicks off with a Pin Exchange, at the National Automobile Museum. Saturday night will cap off the weekend's activities with a Gala and Awards ceremony at the Reno Ballroom that will include some of the artistic works of Burning Man at an Urban Art Party that features street art, a graffiti photo booth, and a DJ to keep the party going.
